JOB PURPOSE

To supervise the children remaining on the school premises at lunch times, including ensuring the health and safety and general welfare of those children.

This job falls within the definition of regulated activity and therefore would be subject to an Enhanced DBS with barred list check.

MAIN DUTIES AND RESPONSIBILITIES

- Assist children in washing etc. in preparation for taking their midday meal and afternoon lessons
- Monitor, interact and support the children's activities, encouraging pupils to play and make use of play equipment prior to, during and after the lunch time meal as required.
- Offer instruction where needed to help pupils to share play equipment and help to resolve issues between pupils during play activities
- Monitor pupils that aren't engaging in play and feedback any concerns to the Midday Supervisor, Class Teacher or duty member of staff
- Assist in the preparation for, and tidying up after, the lunch time meal including setting up and putting away tables, chairs and other equipment needed
- Assist in the conveyance of children between school buildings and manage pupils' entrance and exit from lunch area in an orderly manner
- Encourage pupils to eat their lunch and monitor those who don't, reporting any concerns to the Midday Supervisor, Class teacher or duty member of staff
- Clean up food and water spillages
- Alert headteacher to any health and safety concerns relating to lunchtime activities
- Record details of incidents/accidents in line with the school's reporting

MAIN DUTIES AND RESPONSIBILITIES

- Deliver first aid to respond to minor incidents and refer any major incidents to a qualified first aider
 - Be aware of and support pupils with medical/dietary needs
 - Report any incidents of serious misbehaviour to the Midday Supervisor, Class Teacher or duty member of staff
 - Take necessary action to minimise disruption and harm to pupils
 - Promote the welfare of children and support the school in safeguarding children through relevant policies and procedures
 - Promote equality as an integral part of the role, treating everyone with fairness and dignity
 - Read and follow the relevant school policies, procedures and rules
 - Undertake training required to develop in the role
 - Undertake other related duties as directed by the Midday Supervisor, Class Teacher or the duty member of staff.
